The enclosed building is a total of 94,851 square feet, being split out 71,789 on Level 1 and 23,062 on Level 2. The building height will be 32 ft and 2 inches. The building would have 1 elevator, 3 set of stairs, with 16 mechanical roof mounted units with equipment and 2 main chillers. Portions of the equipment will be concealed, and other portions will be restricted from viewing. The campus would have a 300 KW service generator. The project would include new driveway, flatwork, decking, storm drainage and detention, tree removal and tree planting. New utility light poles and exterior building lighting. New playground equipment with covered canopies and new benches and tables and a new exercise track and playfields and a new monument digital sign with electronic display board located in front of the new school. The project has been designed by Stantec Architects and its representatives and other associated project team members will be discussing the project in detail to the Commission.
