



## **NOTICE OF ADOPTED 2016 TAX RATE**

**The City of Piney Point Village ADOPTED A TAX RATE THAT WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.**

**THE TAX RATE WILL EFFECTIVELY BE RAISED BY 8.33 PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$ 3.56.**

# NOTICE OF 2016 TAX YEAR PROPOSED PROPERTY TAX RATE FOR CITY OF PINEY POINT VILLAGE

A tax rate of \$0.255140 per \$100 valuation has been proposed for adoption by the governing body of City of Piney Point Village. This rate exceeds the lower of the effective or rollback tax rate, and state law requires that two public hearings be held by the governing body before adopting the proposed tax rate.

The governing body of City of Piney Point Village proposes to use revenue attributable to the tax rate increase for the purpose of Maintenance and Operations.

PROPOSED TAX RATE	\$0.255140 per \$100
PRECEDING YEAR'S TAX RATE	\$0.255140 per \$100
EFFECTIVE TAX RATE	\$0.239398 per \$100
ROLLBACK TAX RATE	\$0.254498 per \$100

The effective tax rate is the total tax rate needed to raise the same amount of property tax revenue for City of Piney Point Village from the same properties in both the 2015 tax year and the 2016 tax year.

The rollback tax rate is the highest tax rate that City of Piney Point Village may adopt before voters are entitled to petition for an election to limit the rate that may be approved to the rollback rate.

YOUR TAXES OWED UNDER ANY OF THE ABOVE RATES CAN BE  
CALCULATED AS FOLLOWS:

$$\text{property tax amount} = (\text{rate}) \times (\text{taxable value of your property}) / 100$$
