THE SUBJECT OF THE MEETING ARE AS FOLLOWS:

- 2.) <u>MEETING MINUTES</u>: Matters relating to the approval of minutes from August 28th, 2025, regular Planning and Zoning Commission meeting.
- 3.) NEW SWIMMING POOL DEVELOPMENTS/DRAINAGE COMPLIANCE: Matters relating to the discussion of new swimming pools, particularly when combined with the development of the new single-family homes. The final as built topographical survey required for the closing of the new houses also requires the pools to comply with the current drainage ordinance. However, in most cases the newly developed pools are not meeting the drainage elevation requirements. The pools are being built to a higher elevation than originally designed. City staff, to discuss, with the Planning and Zoning Commission, and recommend amending the current drainage ordinance, set additional criteria for the drainage appeals process, set a fee for the appeals, and establish additional requirements as it relates to the appeals, to ensure and improve overall drainage compliance in all new home developments. Also, to discuss the drainage expedited review fee and to make some additional changes to the city's current expedited review ordinance.
