# A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PINEY POINT VILLAGE, TEXAS, TO RECOGNIZE MAYOR MARK KOBELAN'S COMMITMENT AND CONTRIBUTIONS TO PINEY POINT VILLAGE.

WHEREAS, During his tenure as Mayor from 2016 to 2024, Mark Kobelan provided steady guidance to Piney Point Village and inspired the community to achieve greater heights. Under his leadership, significant infrastructure improvements were made to the streets and drainage systems, including the South Piney Point Drainage Outfall, Blalock Road at Memorial Drive, Piney Point Road, Beinhorn Road, Surry Oaks Road, Dana Lane, Lanecrest Lane, Smithdale Estates, and Wilding Lane. He also oversaw several sidewalk improvements, including parts of Piney Point Road, Beinhorn Road, and Carol Tree Park; and

WHEREAS, Mayor Kobelan played a crucial role in the development of Heritage Trail, including the installation of the Historical Marker at Arrowood Circle, the Historical Marker at 435 Piney Point Rd, and the Historical Panels in Carol Tree Park. He was also instrumental in implementing several beautification, landscaping, and irrigation projects, including those in Carol Tree Park, Flag Tree Park, Memorial Drive Esplanades, South Piney Point Road, Blalock at Memorial, Greenbay Street Corridor, Blalock at Quail Hollow, and Taylorcrest Road at Echo Lane; and

WHEREAS, Mayor Kobelan successfully maintained a low tax rate since 2013 and paid off a substantial bond debt of around \$9.7 million, lowering the bond balance to \$1.7 million. He also steered the implementation of the Over-65 Tax Exemption Ordinance, which increased the amount of assessed value that is exempt from Ad Valorem taxes for homeowners over 65 years old; and

**WHEREAS,** Mark Kobelan's leadership was marked by his unwavering commitment to honor, integrity, and distinction.

### **RESOLUTION NO. 2024.05-C**

# A RESOLUTION AND ORDER OF THE CITY COUNCIL OF THE CITY OF PINEY POINT VILLAGE, TEXAS, TO APPOINT MEMBERSHIP TO THE PLANNING AND ZONING COMMISSION.

**WHEREAS,** The Texas Local Government Code's Chapter 211, "Municipal Zoning Authority," allows municipalities in Texas to regulate land use through zoning ordinances to better public health, safety, morals, or general welfare. This also includes the preservation of places and areas of historical, cultural, or architectural importance and significance.

**WHEREAS,** the governing body of a general-law municipality can appoint a zoning commissioner. By City Ordinance, the planning and zoning commission must be composed of eight members, each of whom must be a resident citizen, qualified voter, and property owner of the city.

WHEREAS, the commission members must be appointed by the mayor, subject to approval from the city council. Any member of the commission may be removed at the mayor's will, subject to the concurrence of the city council.

# NOW, THEREFORE, BE IT RESOLVED AND ORDERED BY THE CITY COUNCIL OF THE CITY OF PINEY POINT VILLAGE, TEXAS:

	<u>Section 1</u> . The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this resolution for all purposes and are adopted as a part of the judgment and findings of the City Council.
	Section 2. The City Council hereby finds that qualified citizen is appointed to serve on the City of Piney Point Village Planning and Zoning Commission as the Zoning Commission Chairperson.
	<u>Section 3.</u> That it is hereby officially found and determined that the meeting at which this resolution is passed is open to the public and that public notice of the time, place and purpose of said meeting was given as required by law.
	Section 4. This resolution shall be in force and effect from and after its final passage, and it is so resolved.

# **Summary**

The City requested that HDR provide an assessment of the existing school zone signage and recommendations for improvements required to bring the signage into compliance with the Texas Manual on Uniform Traffic Control Devices. An Opinion of Probable Construction Cost for each school zone will be provided at the City Council meeting, and HDR and City staff are requesting directions on the path forward.

It is important to note that the installation of new school signage and reduction of speed limit zones must undergo the ordinance process. The timeline for adopting this ordinance is tight, as it needs to be approved before the zones can be enforced for the new school year. Our team will collaborate with the schools to determine the placement of school zone signage, the timing of reduced speeds, the positioning of crosswalks, and the use of crossing guards.

# **Recommendations:**

The council may want to recommend that Planning and Zoning begin drafting an ordinance regarding school zones.
