	Decking Permit Application	This application is required for any new pool decking.	Decking Permit Application
	Copy of Survey	A copy of an existing survey is required with this application request. Survey copies do not need to be brand new.	*Attach Copy of Survey
	Area Calculations	Area calculation form is required to determine current and proposed lot coverage. Pools are counted into lot coverage.	Area Calculations Form
	Homeowner Affidavit	This form is required to be completed. If in an active Homeowner Association neighborhood, you must have an HOA Approval. If not in an HOA, then the form still needs to be completed. If in an active HOA, an email approval or stamped approval is applicable.	Homeowner Affidavit Form
	Electrical Load Analysis	Electrical load analysis is required to show how the existing service will handle the new load.	Electrical Load Analysis Form
	MVWA Approval	The Memorial Village Water Authority must approve your new pool application.	MVWA Application
	Pool Form Survey Acknowledgment	This form must be signed by the pool company. A pool form survey is required after the stake out inspection has passed. The city will review the form survey.	Form Survey Acknowledgment
	Tree Disposition Plan	The form needs to be completed regardless of whether no trees are to be removed. City Forester reviews all applications. Show pool access and dumpster location.	Tree Disposition Application
	Friendly Neighborhood Letters	Friendly neighbor letters are submitted as part of your New Pool Application. The letter must be stamped and unsealed and turned into the city. The letter must include an estimate starting date and a point of contact for any questions or concerns.	*Attach Letters
	Barrier Requirements	All doors leading to the back yard and all fence gates must meet the pool barrier code requirements specified in the IRC 2018.	Barrier Requirements for Review
	Pool Job Card	Help sheet on all required inspections. Must be on the job site.	Pool Job Card
	New Pool Construction Drainage	All new pools must have a professional engineered drainage plan. All drainage must be stamped and uploaded to the city website. Drainage must include the elevations of the pool, coping, decking and perimeter elevations.	Drainage Plan Requirements Form <small>(updated 1/1/2026)</small>
